Memorial to Captain Arthur Phillip

By letter dated 22nd October 1974, the Rev. G. C. C. Spencer, vicar of Bathampton Church, Bath, England, has advised the Fellowship that the Memorial to Captain Arthur Phillip was now in place, and the Australia Chapel was nearly complete.

"The Bishop of Bath and Wells has agreed to dedicate the Chapel and Memorial on Sunday 26th January 1975 at 3 p.m.

"As a representative of the Fellowship of First Fleeters is required to take a speaking part in the service I shall be grateful if you will decide who is to do this and to let me know as soon as you can. When the invitations and orders of service are printed I can then send him/her copies.

"You will also be pleased to know that the workmanship and design of the Memorial are quite first-class."

As members know, the Phillip Memorial is the gift of the Fellowship following an appeal for funds in 1969-70. (For further details of the Memorial, see the August 1974 F.F.F. Newsletter).

For the representative of the Fellowship to participate in the service, will any member be in England at that time who will be happy to represent the Fellowship? Or, failing that, does anyone know of any member who will be over there at the time, either visiting or residing, who would be prepared to take part?
