From the President

Whilst I have only been back in Australia a few days I can truthfully jit is good to be back. There is no place like one's own country.

It was the most wonderful experience to represent the Fellowship at such an historic event as the unveiling of the Australian Settlers Memorial by Her Majesty the Queen at Portsmouth on Friday 11th July 1980.

The three Official Australian Guests were the Lord Mayor and Lady Mayoress of Sydney and the President of the Fellowship of First Fleeters. We travelled to London on the same plane and had a few days to recover from the trip — the Lord Mayor and Lady Mayoress in London and I with Mrs Margaret Green, at Portchester, near Portsmouth.

I was assured it would rain, as Her Majesty had never visited Portsmouth on a fine day! But the day dawned bright and clear, the weather couldn't have been kinder.

A Formal Luncheon was held at the Guildhall, and I was honoured with a place on the Official Table, together with the Australian High Commissioner, Sir James Plimsoll, the New South Wales Agent-General,

In such illustrious company one can scarcely do anything but thoroughly enjoy it. The Loyal Toast was proposed by the Lord Mayor of Portsmouth. The toast to Australia and Britain was proposed by Mr Spraggs and responded to by Sir James Plimsoll and Lord Slim. At the conclusion of the meal all 120 guests were transported by bus to the site of the Memorial at Sally Port. I was one of twenty to be presented to the Queen. Literally thousands of people lined the

streets, and Her Majesty chose to walk, much to the delight of the The scene was very colourful, with an Army Band in red dress jackets and the walls, so many hundreds of years old, topped by a detachment in uniforms of 1788 vintage. There was an air of great excitement as we waited for Her Majesty to complete the long walk, but as the cheering grew louder, so we knew she was coming closer. A petite figure in cornflower blue, accompanied by the Duke of Edinburgh in full Naval uniform, she was greeted by a fanfare of trumpets.

When I was presented she showed great interest in the Fellowship and expressed her pleasure that I was able to attend. Then, as the Queen approached the dais, guns thundered in salute in Portsmouth Harbour and jet fighters swooped in overhead. As Her Majesty released the Union Jack and the Australian Flag covering the sculpture there was long and loud applause followed by the playing of "Advance Australia Fair". The ceremonial marching was something that must be seen to be I really feel no one can do that type of thing like the believed: British.

Sitting at this spot in Portsmouth I had a very strange emotional feeling, as I looked at the gate through which, 193 years ago, my ancestors walked in chains, to face an unknown future. Yet here was I, five generations later, an honoured guest of the City in the presence of Her Majesty the Queen. I certainly felt very proud.

Afternoon tea was served at the Guildhall, and as this was less formal it was an opportunity to mix and speak with interesting people from all walks of life.

At night a formal Dinner was held, with the Lord Mayor and Lady Mayoress of Sydney and myself as Guests of Honour. This was held in the Lord Mayor's Private Parlour at the Guildhall and was an absolutely I was transported to and from this function in magnificent spectacle. the Lord Mayor of Portsmouth's Rolls Royce.

It was a very long but exciting day, and I can assure all Members that the Fellowship of First Fleeters is held in very high esteem in Portsmouth.

Would all Members please take note of the date change for the Annual General Meeting? This has been brought about by the fact that the First Fleet Memorial in Sydney Cove is to be unveiled by His Excellency the Governor-General on 17th September, 1980. At this stage the time has not been fixed, but your Executive Committee felt it better to postpone, for one week, the Annual General Meeting, to leave everyone free to attend. Years of work and effort have gone into this Memorial, and it is good to see it a reality. Whilst on this subject, may I correct a statement in last month's Newsletter -- the granite base for the sculpture was given by Portsmouth City Council, not the Historical Society.

I look forward to seeing many Members at both the unveiling ceremony on 17th September and the Annual General Meeting on 24th September 1980.

Lecture Reports

(June Lecture)

Our June Lecture Night welcomed again Mr Robert Irving. His subject this time was "The Lost Windmills of Old Sydney".

Mr Irving, Senior Lecturer for the School of Architecture, University of New South Wales, certainly knows and loves this fascinating subject. The slides he brought were beautiful, and there is a certain atmosphere to a picture of an old windmill, and artists featured them in the early sketches and paintings of Sydney. They are beautiful structures, and intriguing ones.

Mr Irving kindly gave each of us printed copies with the chronology of the early Sydney grain mills. The chronology was compiled by Robert Irving in 1979 He has spent years in researching these early mills.

The first Sydney mill was erected in 1793 on the parade ground. The owner/builder was John Baughan. a capstan type, a nine-man mill.

There was another early mill on Observatory Hill, The Rocks, and it was a stone tower. The scale model and machinery was brought from England · in 1795, but the mill closed by 1806. Nathaniel Lucas had a mill at

Millers Point built in 1812, and also one on Flagstaff Hill built in 1805. This latter mill survived till the 1820s. It is sad to think that these buildings have gone, with only the artist's pictures to remind us of their existence.

The lecture was extremely interesting, and Mr Irving is a talented speaker.

(July Lecture)

The July Lecture was to have been given by Mr John M. Bennett, Legal Historian and author, but unfortunately he was unable to attend. The change of speakers for the evening could not be mentioned in the News-letter, as the lecture was cancelled only five days before the Lecture Evening and the Newsletter had already been printed and posted to Members.

Mr Bennett kindly asked Mr David Earle to take his place. Mr Earle is an architect working for the Sydney City Council on the restoration of the Queen Victoria Building. This lecture was a great success, and Mr Earle a most interesting guest speaker who obviously loves the beautiful cld building.

The Queen Victoria Building was built during the depression of the 1890s in the short space of five years and cost £261,102/10/9. Designed by City Architect George McRae, it was intended to replace the old Queen Victoria Markets. Meant to resemble a Byzantine palace, the building contained a two-level arcade of shops for its full length, with covered markets below. The building had four hydraulic lifts which took carts and lorries with their horses from York Street to the lower level.

The building is constructed of Waverley sandstone external walls, with the ground floor columns of finely dressed Bowral trachyte. Floors were tiled in coloured geometric patterns, some of which still remain. Two of the original six elegant stairways are still in existence. All joinery was in Australian cedar, and considerable use was made of stained-glass windows. The roof, vaults and domes are steel-framed. The main dome is clad with copper sheets, and the lesser domes with Muntz metal. The building has housed the City Library since 1899.

Mr Earle showed us many outstanding slides of the Queen Victoria Building, and said that people either love or hate the old building; though it's hard to believe anyone could hate it after such a memorable lecture. We hope David Earle will return as our guest in 1981.

Mr John Bennett will be coming to speak on "The Early Magistrates of Sydney" some time early next year, and we look forward to meeting him.

(Coming Lectures)

The Lecturer for this month's Lecture, on 20th August, has been changed. The Lecture will be given by Mr Nigel Ashton, who will speak about Elizabeth Farm. "Mr Ashton is a member of the Royal Australian Historical Society, and has recently written about Elizabeth Farm in the R.A.H.S. Journal.

After the Annual General Meeting on 24th September Mr Geoff Squires will speak to the Fellowship about Norfolk Island. His address will be given in two sections (the second section if time permits). The first section will be titled "Norfolk Island as the First Fleeters Would Have Seen It" and the second section "The Tour of 1980". Mr Squires, a Member of the Fellowship, is a very interesting speaker, and we look forward to the evening closing with an entertaining talk.

There will be no lecture as such in October (15th October). The President, Mrs Lewis, will speak about her recent visit to Portsmouth, and this will be followed by the opportunity for Members to raise Fellowship matters of interest or concern which will be answered by the President or some other member of the Executive.
