## **EXECUTIVE COMMITTEE REPORT**

One of the questions often asked at Executive Committee meetings, "Do our members read the Newsletter?", had an unexpected answer in the replies we received from our questionnaire on the naming of the proposed new university in the western part of Sydney after Governor Phillip. We can now confidently state that at least one in nine members read the Newsletter and are sufficiently motivated to complete and return a questionnaire. The response was a great surprise and, had there not been four dissenters, there would have been a unanimous vote for Arthur Phillip's name to be given to the University. The Committee has now written to the Australian and NSW ministers for Education and advised them of your support for this proposal. Thank you for your enthusiastic response.

At the May meeting of the Executive Committee Mr. R. Best tabled the new draft constitution, which has now been thoroughly examined and agreed to by the Committee. The Committee is conscious of a very great debt to Mr. R. Best for his contribution in preparing the draft, not only for his legal experience in preparing a legalistic document, but also for his experience as a Past President, former Vice-President, member of the Executive Committee for many years and currently Treasurer of the Fellowship, and applying the knowledge so gained about the Fellowship to the preparation of this very important document. This is the eighteenth year of the Fellowship's existence and it seems appropriate that, in a modern sense, the Fellowship is now "coming of age" by the adoption of this new constitution which will confer a new status on it and its members. A formal notice elsewhere in this issue gives details of the Special General Meeting to be held.

Long-standing members will recall that the addresses of new members used to be published in the Newsletter. Following complaints from some members that they were receiving unwelcome enquiries from persons who had access to the Newsletter in public libraries, to which the Fellowship is required by law to supply copies, the Executive Committee decided to cease publishing the private addresses. Arrangements were made for the Fellowship's office to forward any mail when one member wanted to contact another member. This procedure has worked generally well. Recently some country members have requested that the addresses of other country members be published periodically in the Newsletter with a view to promoting better fellowship among those who are cut off from the facilities offered to Sydney metropolitan members. The Committee recognises the merits in both arguments and is interested to know what your views are, so please write indicating your approval/disapproval of either policy or make constructive suggestions for a different solution.

A facility offered by the Fellowship to all its members, but not generally appreciated, is its extensive library about the First Fleet now under the care of librarian Janette Beard. The Fellowship is affiliated with many other historical and genealogical societies and family history groups and receives from them copies of their journals and newsletters, which often contain interesting articles about the people of the First Fleet. Recently the Fellowship added to its microfilm collection a set of the Convict Indents obtained from the NSW Archives Office. These acquisitions can make a visit to the Fellowship's office not only an agreeable social occasion but an informative one too.

#### **GRAVES REPORT**

A record crowd was present on Sunday, 20th April, 1986 at the Christ Church, Kiama for the dedication of a plaque attached to the tombstone of Marine John Gowen, who had sailed aboard the HMS Sirius with the First Fleet.

Descendants came from Bateman's Bay, Canberra, Goulburn, Gateshead and Sydney to pay their respects. The church was packed with standing room only.

Vice President Douglas Oakes was master of ceremonies due to the President being overseas. Michelle Hapgood, a sixth generation descendant of John Gowen, read the history of her ancestor. (This will be printed in a future issue of the Newsletter.)

John Gowen was born around 1763, enlisted in the Marines in 1778 and arrived here as a corporal of the Marine. He first married Ordery Appleyard in 1805 and they had four daughters and one son. He married for the second time, as a widower, Mary Wood in 1821. John Gowen passed away 28th April, 1837 whilst visiting his married daughter Frances in Kiama.

The Mayor of Kiama, Alderman Arthur Campbell, lifted the Queen Anne flag which draped over the tombstone, thereby dedicating the attached plaque, and in his speech congratulated the Fellowship in honouring Kiama with this service. The tombstone will now be featured in Council literature as an important historical site for visitors to see.

The Rector of Christ Church, Kiama, Rev. Stephen Gabbot, ended the service with a short dedication prayer.

The descendants of John Gowen then gathered around the tombstone for the many photos that were taken to commemorate this historical gathering.

Thanks are extended to Geoff Squires for organising the day and attaching the plaque to the tombstone. Douglas Oakes

#### SPEECH AT F.F.F. GRAVE COMMEMORATION ST. PETERS, RICHMOND ON SUNDAY 20th OCTOBER, 1985

Mr Christian, Mr Pilcher, Councillor Stubbs, Ladies and Gentlemen.

We are meeting here today to pay our respects by the dedication of a plaque to First Fleeter, Thomas Spencer, who died on "his farm" near Richmond Hill on 3rd February, 1821.

At the age of 27, Thomas Spencer came to Australia with the First Fleet on the transport ship "Scarborough" being at this time a Private of The Marines. The Society of Australian Genealogists advises that there are no records which give background, birthplace or previous military service of the Marines who served on the First Fleet. The Norfolk Island Victualling Book indicates that he reached the island on 4th November 1791 as a Marine Settler "from the detachment" (having been in Captain Shea's Company). On the 24th November he leased 60 acres of land that should rightly have been issued as a "grant forever." Lands Grants Records of 1795 state — "Thomas Spencer leased 60 acres at a rent of 3 pounds per year for 14 years commencing from 24th November 1791". Then a memo states "The original possessor of annexed farm had by some mistake received it only upon lease of 14 years, when as a settler from the Marine Corps he was entitled to have had it, as others in similar situations and circumstances had, a grant forever - it is now to be considered as a grant in the usual way to the present possessor, Mr Zachariah Clark. 4th September 1799. Signed --- John Hunter.'

"Historical Records of Australia in a 1792 list of Land Grants on Norfolk Island, shows "Thomas Spencer ---private, Marines, Unmarried, 60 acres."

However, on 27th November 1791, a Mary Phillips, a First Fleeter 18 year old lass who had been convicted for stealing and been transported for 7 years and who had arrived on Norfolk Island on the Sirius which was shipwrecked on arrival at the island, gave birth to a daughter Sarah — of whom Thomas Spencer was the father. This is a confirmed in a family prayer book handed down by Susan Smith (later to become Thomas Spencer's wife) to Charles Hadley who married his daughter Sarah.

In 1794, the Officer-in-Charge on Norfolk Island Lieut. Governor King, described Thomas Spencer in the official records as being "... a settler of unexceptional character". I would like to point out that the word "unexceptional" worried me ... until I went to my dictionary. The old time meaning is (and I quote) — "not open to criticism, beyond reproach; satisfactory, excellent". We can take it that Thomas Spencer was a man "not open to criticism, beyond reproach; satisfactory, excellent character". This eulogy resulted from information offered by Spencer, other settlers and convict to an official enquiry re a possible mutiny by the convicts, because of the unnecessarily harsh treatment by the military. King subsequently took steps to disarm the military.

Thomas Spencer departed Norfolk Island on 8th August 1795 "on leave to Port Jackson" but returned to the Island on the "Supply" in October the same year. Then again, in April 1796, he returned to Sydney and again by "Supply". In 1802 his next land grant is shown as 100 acres in the district of Mulgrave Place. Little is known from this date until the 1814 Windsor Muster which shows that he had settled on a farm together with a wife Susan Smith a woman who had come to Australia on the "Indispensible". Unfortunately little appears to be known, at Present, of this branch of Thomas Spencer's family.

Thomas Spencer continued farming in this district until his death over 164 years ago — on 3rd February, 1821. He leaves hundreds — if not thousands of descendants — both here in Australia and in lands overseas — even to the ninth and tenth generations. His own daughter, Susan —born on Norfolk Island and later to marry Charles Hadley of Castlereagh, has a direct descendant, Jackie Flowers, still in residence at the original Hadley Park built in 1821. For those of you going on to the old Castlereagh Cemetery this afternoon — you'll find Hadley Park (the original) in Castlereagh Road almost opposite the turn off at Church Lane.

On behalf of this "unexceptional man" ... may I, with gratitude and respect, ask Councillor Stubbs to dedicate this plaque on First Fleeter, Thomas Spencer's grave.

#### ELIZABETH ROPE

The following address was read by Mary Hope Caten at the plaque dedication ceremony at Castlereagh Cemetery on 20th October, 1985.

"We are gathered here today to honour our forebear Elizabeth Rope,

Born Elizabeth Pulley, possibly in 1761, she lived in the small town of Hethersett in the County of Norfolk, and was first convicted in 1779 for stealing food and clothing. On the night of December 24th, 1782 Elizabeth broke into the shop of Mrs. Elizabeth Minns, a widow, of Hethersett, and stole 2 cheeses, 4 pieces of bacon, several ½ pints of butter, ¼ stone of raisins, ½ stone of flour and 2 rolls of worsted. She was tried at Thetford on the 14th March 1783 and received the sentence of death, but later was reprieved and imprisoned in Norwich Castle until November 1786. A paragraph in the "Norwich Mercury" of 1st November, 1786 reads:

"A few days since, a letter was received by Mr. Gynne, keeper of the Castle, signifying His Majesty's pleasure that Elizabeth Pulley, Susannah Holmes and Ann Turner (three convicts under sentence of transportation) should be conveyed to Plymouth in the course of the first week in November, and there put on Board H.M. Ship "Dunkirk" bound for the new settlement at Botany Bay. They were accordingly last Monday taken from the said gaol and seemed not in the least dismayed at the length of their voyage or of their future fate." (The Dunkirk was a hulk.)

In May, 1787 Elizabeth, now aged 26, joined the transport "Friendship" and sailed with the First Fleet bound for NSW. When the fleet arrivd at the Cape in October several of the women convicts were transferred to the "Prince of Wales". Elizabeth was among them, and their places were taken by sheep bought for the colony.

On arrival in Sydney Cove, Elizabeth Pulley married Anthony Rope, late of the parish of Rochford Essex, another convict, who arrived in the "Alexander" with a 7 year sentence for stealing. The marriage took place on the 19th May, 1788, with Elizabeth mason and John Summers as witnesses.

On Sunday the 25th May a supper party was in held in the Rope's tent to celebrate their wedding. The guests dined on sea pie which contained fresh meat. Capt. Collins examined Joseph Hatton, a wedding guest, concerning the disappearance of the goat, the property of Lt. George Johnston. Anthony and Elizabeth Rope, James Price and Samuel Day were committed for trial. Evidence was given the goat was found dead as though killed by an animal and Anthony Rope and John Price had taken the liberty of cutting some flesh to make a pie for the wedding dinner. All were acquitted.

Elizabeth was not before the courts again in the colony. On Sunday, 2nd November, 1788 the first son of Anthony and Elizabeth was christened Robert. He is claimed to be the first white male child conceived and born in Australia. Robert married Esther Mary Gambol in 1812.

The Rope's first daughter was christened in 1791, and named Mary. She had two children to Lt. Thomas Hobby, and married John Michael Ryan in 1816.

A grant of land comprising of 70 acres was given to Anthony Rope in 1792. This grant was at the Ponds, a settlement two miles N.E. of Parramatta (now Kissing Point Road, Dundas). Another daughter, Elizabeth, born in 1794, possibly died in infancy. John, born in 1795, who married Maria Field in 1817, and Sarah, born in 1798, who married Thomas Frost in 1815, were all registered at St. Johns, Parramatta.

By the early 1800's the family was residing on 40 acres of land rented from James Badgery on the Nepean. Susannah was born, possibly in 1801, and she married John Bradley in 1818. William born in 1805 remained unmarried. Their last child Elizabeth Ann was born in 1808. She had a son James to William Jones and married Thomas Player in 1826.

By 1828 Anthony and Elizabeth had 11 acres of land, all cleared and cultivated, and 5 horned cattle. They were together 49 years, most of the time spent in the district of Evan with their children, grand-children and greatgrandchildren living close by the area known as the suburb of Rope's Creek.

Elizabeth died in 1837 and is buried next to her son William and grand-daughter Eliza Frost, and possibly Anthony is buried here but no headstone remains. She saw the beginnings of the colony and lived through the hardships of famine and floods. We are proud to be descended from Elizabeth Rope, truly one of Australia's founding mothers."

#### THE SELECT FEW

It has always been believed by the majority that those convicts to be sent to the new colony of New South Wales were only persons possible to have been selected for the journey.

What is little known is that the chosen few were in many cases envied by a number of free persons who made attempts to gain passage to travel to the new land.

Upon reading an article entitled "A London Newspaper on the Founding of Botany Bay, August 1786 — May 1787" by Ged Martin (RAHS Journal Vol. 61, p.2) I was most interested to find reference to such cases. I felt it would be valuable to relate some examples from the article.

"The Home Office received almost daily application through the autumn of 1786 from skilled tradesmen who could not find work in England. According to the newspaper 'The Register', it did not know "whether they would be accepted" but a limited number of several different professions we suppose, will of necessity have leave to go. Some evidently thought of New South Wales as another Bengal, where there was easy loot to be had. Public belief in the riches of the colony was shown by the vast number of persons daily applying for leave to go out to share the fortune of the new colonists".

One wife and mother of the felons wanted passage. A group of women called at the Treasury begging to be allowed to accompany the expedition. The Treasury dismissed the idea as absurd. The Under Secretary, Evan Nepean, promised their case would be considered. According to this newspaper, the matter was referred to William Pitt. The economy of the expedition, however, would not allow for such privileges, so the requests were refused.

The idea of a new colony with only felons as settlers did not decrease the crime rate.

Some deliberately went about seeking to be arrested for sentence and a trip to the new land. One soldier deliberately committed robbery "in order to be sent to Botany Bay". He was, however, unlucky enough to be sent to the African colonies instead! One unfortunate young man refused to accept a reprieve from the gallows because his girlfriend would not marry him. She changed her mind and he apologised for his obstinacy and begged unsuccessfully to join the expedition. Other convicts were sent to Tristan da Cunha to help southern whalers. Still others were sent to the coal mines of Blackheath. So it seems that the "selected few" were select indeed, and for those who lived and prospered finally in the new colony, maybe after all, they were the lucky ones!
